Surface Preparation:

Substrate must be sanded using 120, 150 or 180 grit paper prior to staining or coating. Sealer should be sanded with 280/320 grit paper prior to being coated. Appropriate sealer is the ora Verde Unico 436-6601. When recoating, the previous coat of Unico must be sanded and the next coat applied within eight hours. Stain systems used under ora Verde Unico are formulated to develop excellent grain definition. AkzoNobel recommends using Promatch® W/B Monocolor Spray Stains 824-50XX, Promatch Aqua Stains 824-51XX, Promatch Dye Stains 890-85XX or Promatch C-Mix Wipe Stains 825-90XX, 825-91XX.

General Information:

Oil stains must be avoided because they will interfere with the adhesion. When coating exotic woods (Teak, Rosewood, etc.) a barrier coat (tie-coat) should be applied before the sealer or base coat.
